# **Statutory Summary**

Address confidentiality programs vary from state to state. There are, however, some similarities throughout the states, such as all states including an experience of domestic abuse or violence, sexual assault, and stalking in their statue to be eligible to participate in the program. The majority of states have exceptions to the confidentiality of the address, and the majority of states will forward the mail of the participant to their actual address. Five states and four United States territories do not have any kind of address confidentiality program. (Alabama, Guam, North Dakota, Northern Mariana Islands, Puerto Rico, South Carolina, South Dakota, Virgin Islands, Wyoming.)

#### Persons Eligible to Participate in Address Confidentiality Program

All of the states include domestic abuse/violence as a requirement to be eligible for the address confidentiality program. Some states require more than domestic abuse/violence to be eligible for the program. To be eligible to participate in the address confidentiality program, twenty-three states require a survivor to fear for their safety were their address to remain nonconfidential. (Alaska, Arizona, Delaware, Florida, Indiana, Iowa, Kansas, Maryland, Massachusetts, Minnesota, Mississippi, Missouri, Nebraska, New Hampshire, Oklahoma, Oregon, Pennsylvania, Rhode Island, Utah, Vermont, Virginia, Washington.) Nine states require a survivor to show proof of abuse to be eligible for the program. (Arkansas, California, Connecticut, District of Columbia, Idaho, Maryland, Montana, Texas, Wisconsin.)

### **Forwarding of Mail**

For participants who are eligible for the state's address confidentiality program, thirty-five states will forward the participant's mail to the confidential address. This includes first class, registered, and certified mail. (Alaska, Arizona, California, Colorado, Delaware, District of Columbia, Hawaii, Idaho, Illinois, Iowa, Kansas, Louisiana, Maine, Maryland, Massachusetts, Michigan, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, Ohio, Oklahoma, Oregon, Pennsylvania, Tennessee, Texas, Vermont, Virginia, Washington, West Virginia.) Only Pennsylvania explicitly states that any kind of mail other than first class, registered, and certified mail will be forwarded at the expense of the participant.

#### **Exceptions to Confidentiality of Address**

Forty-three states allow for exceptions to the address confidentiality of the participant. (Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, District of Columbia, Florida, Hawaii, Idaho, Illinois, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New York, North Carolina, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin.)

Eighteen states will release the confidential address of the participant if presented with a bona fide or legitimate need by an agency for the address. (Alaska, Arkansas, California, Colorado, District of Columbia, Florida, Hawaii, Illinois, Maine, Massachusetts, Michigan, Minnesota, Mississippi, Nebraska, New Jersey, Texas, Utah, Vermont.)

Nineteen states will release the confidential address by court order. (Arizona, Delaware, Idaho, Iowa, Kansas, Kentucky, Louisiana, Maryland, Montana, Nevada, New Hampshire, New York, Ohio, Oklahoma, Rhode Island, Tennessee, Texas, Utah, Vermont.)

Fifteen states will release the confidential address of the participant when officially requested by law enforcement. (Connecticut, Idaho, Kansas, Kentucky, Louisiana, Maryland, Montana, Nevada, New Hampshire, New York, Ohio, Rhode Island, Tennessee, Texas, Vermont.) Four states allow disclosure of the confidential address if a state or local agency or the public body requests disclosure in writing. (North Carolina, Oregon, Pennsylvania, Tennessee.)
