Solve Disconnection

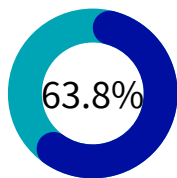
We bridge the gap between systems and communities by actively involving community leaders and organizations in creating culturally relevant solutions that center survivors and reflect their unique needs and desires.

Look to The Future

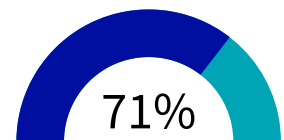
We envision a world where gender-based violence responses are adaptable and culturally specific, ensuring every survivor receives meaningful support tailored to their community's unique needs.



54% of Black women, **58%** of American Indian or Alaska Native women, over **40%** of Hispanic women, and **63.8%** Multiracial women have experienced intimate partner violence in their lifetime. ¹

On just one day, survivors across the country made **12,692 unmet requests** for services that domestic violence programs did not have the resources to provide.²



75% of survivors who called the police wanted their involvement at the time they called, but **71%** said they would have chosen other resources instead if available. ³

Reimagine Coordinated Community Response With BWJP

For over 30 years, BWJP has and continues to provide training and technical assistance (TTA) to support the implementation of Coordinated Community Response (CCR) among jurisdictions exploring CCR, implementing CCR, and enhancing existing CCRs.

We also provide TTA to support jurisdictions that are invested in our core principles of Reimagining CCR. The core principle of BWJP's Reimagined Coordinated Community Response (RCCR) is prioritizing the needs and experiences of marginalized survivors and their families. This resource explores the limitations of the traditional CCR model for marginalized survivors and offers BWJP's vision for a RCCR that works for **all** survivors and **all** communities.

Bisexual+ Survivors Report

For decades, systems professionals have been attempting to address the problem of intimate partner violence through the work of Coordinated Community Response (CCRs). The results have been promising for certain types of survivors. Often the needs of groups who are white, cisgender, heterosexual, and not living with a disability have been addressed by CCRs. This report examines the experience of bisexual+ survivors of intimate partner violence due to the alarming statistics concerning violence against bisexual+ women and the lack of resources in the field that address barriers and systemic bi-antagonism existing within systems.

Deaf and Hard of Hearing Survivors Report

It is well known that CCRs have had numerous challenges in accommodating the needs of diverse survivors from various marginalized communities. As part of this project, BWJP focused on two communities: LGBTQ+ and Deaf communities. By using the principles of survivor-centered design, and listening to survivors from these communities, we hoped that we would offer CCRs and other jurisdictions ways to create programs and designs that were culturally and linguistically responsive.
