#### ADVOCACY

The National Center on Systems Change and Advocacy is a practice-based center that allows advocates and systems professionals to create new solutions both within and outside the legal systems that have the capacity to give back agency to individuals and communities.

The Center on Global Rights for Women (formerly Global Rights for Women) works with advocates and leaders around the world to advance women and girls' human right to live free from violence through legal reform and institutional and social change.

NATIONAL CENTER ON REIMAGINING COORDINATED COMMUNITY RESPONSE

The National Center on Reimagining Coordinated Community Response establishes approaches and support for centering survivor and culturally specific realities, for advocates and allied professionals to positively shift community and survivor interactions with systems.



Inspired by the U.S. National Plan to End Gender Based Violence, MOSAIC, a project of RCCR, helps states and local communities strengthen their response to intimate partner violence, sexual assault, stalking, trafficking, and other forms of violence against women.

The National Restraining Order Center (NROC) is the Nation's preeminent resource on the issuance, service, and enforcement of protection orders for survivors of domestic and dating violence, sexual assault, and stalking.

#### CHILDREN

NATIONAL LEGAL CENTER ON CHILDREN AND DOMESTIC VIOLENCE

The National Legal Center on Children and Domestic Violence advises parents who are survivors of intimate partner violence and their attorneys on the intersection of domestic violence and family court.



Safe Access for Victims' Economic Security Center (The SAVES Center) works to ensure that every survivor who wants and/ or needs child support and parenting time services receives this aid from a trauma- informed, equitable, and culturally responsive child support program.



### **GUN VIOLENCE**

NATIONAL CENTER ON GUN VIOLENCE IN RELATIONSHIPS

The National Center on Gun Violence in Relationships works to prevent domestic violence related assaults and homicides involving firearms. The National Resource Center on Domestic Violence and Firearms is a critical project within the National Center on Gun Violence in Relationships.



The National Resource Center on Domestic Violence and Firearms (NRCDVF), is operated by BWJP. They provide expertise, training, consultation, and technical assistance to prevent abusers use of firearms violence against victims and survivors of domestic violence.



The Firearms Technical Assistance Project (FTAP), a project of NCGVR, partners with communities across the country to implement policies and practices to prevent abusers from having access to firearms in domestic violence cases.
